This standard incorporates Amendment No. 1 (2024). The changes introduced by amendments are indicated in the text by a marginal bar and amendment number against the part affected. Where an application date other than immediate is applicable to an amendment, the date of application (DOA) and the date of withdrawal (DOW) if relevant, are indicated by the marginal bar against the part affected. Unless otherwise indicated, the application date of the changes introduced by Amendment No. 1 is gsgrtr 202x.
